


MID 2004/22/EC, MID 2014/32/EU AND THE WEIGHTS AND MEASURES ACT (MESSEGE)

We have already submitted our application for accreditations for the MID Directive 2014/32/EU coming into force in April 2016, as well as for the new Weights and Measures Act (MessEG).

Our test centre for electricity meters was the first officially recognized private certification body in Germany for electricity meters covering Annexes B, D and F.
